

# CONSTRUCTIVE NOTICE AND REQUIREMENT TO PERFORM

There is also the fact that JSM is directly responsible for the deaths of 134 sailors, and seriously injured another 161sailors, on the USS Forrestal on the 29<sup>th</sup> July 1967.

This was due to JSM doing a ‘wet start’ of his aircraft’s engine as an attention-getting stunt. This and the large subsequent electrical surge and apparent (incorrect and against policy) weapon arming (by JSM) caused the launching of a powerful Zuni rocket across the carrier’s deck hitting other parked planes (photo below) that were

packing 1,000 high-explosive pound bombs. The subsequent massive explosions, fire and destruction went several decks below and nearly sunk this major 82,000 ton U.S. aircraft carrier.



The Navy subsequently covered up this incident because JSM's father was an admiral at the time that this incident occurred and was able to pull the strings to make this incident 'disappear'.

It is therefore demanded that as a point of *National Security* that John Sidney McCain be made a public example of for all the crimes he has committed while in the service of his country, which must include the Navy coming clean publicly about what occurred on the USS Forrestal on 29<sup>th</sup> July 1967.
